Note:- A candidate shall be eligible for recruitment to the post of Group C and D, if he/she has passed matriculation and +2 from any Institution/ School/ Board situated within Himachal Pradesh.(Provided that this condition shall not apply to Bonafide Himachalis).

The one post of Clerk cum Data Entry Operator and two post of Clerk Account are to be converted into the general cadre of clerks.
