#### About the University

The Himachal Pradesh National Law University, Shimla (HPNLU, Shimla) was established by the State Government in 2016, by an Act of the Legislature (HP). Under the guidance of the Hon'ble Chancellor, HPNLU Shimla, conceived its present form and is continuously evolving since. The University started functioning in October 2016 and inducted its first batch of students on the basis of CLAT/ SNAP/ ALICT merit. The University began inducting students into the various courses viz. – B.A. LL.B., B.B.A. LL.B., LL.M., and Ph.D. from 2017. The University is part and parcel of CLAT consortium.

In 2019, HPNLU, Shimla organized its second conference, International Conference on Human Rights, Democracy and Human Dignity: 70 years of Universal Declaration of Human Rights. The conference witnessed participation from various sections of the legal fraternity including but not limited to members of the judiciary, lawyers, and academicians, among others. In the present scenario, where due to Covid-19, academia has suffered a lot, the HPNLU, has taken all possible steps to keep on learning via e-mode. # About the Batch 2021

The students of the Batch have been very energetic and up to the expectations. They have been the part and parcel of the evolution and growth of the University. The students have striven hard to come up to the challenges posed by the rapidly changing legal world. Students have been enthusiastic participants and winners in moot courts. Their inquisitiveness may be seen in the research papers presented by them. Despite of not having own infrastructure, full-fledged library and limited resources, in the early years of their life at the University, the Batch has performed remarkably. The first child of the family gets the unbound love and affection but the same time has to cope of with the scarcity, has been the situation with this Batch. The Batch is determined and consistent.

# **Evaluation and Marking process**

The Batch 2021 is B.A. LL.B. (Honours) batch comprised of 53 students. The evaluation and marking process at HPNLU, Shimla is comprised of rigorous system of examinations, assignments, presentations, attendance and moot courts. At the end of each semester every student is evaluated for 100 marks for each subject.

Credit connotes the unit that gives weight to the value level or time requirement of a course. 01 Credit shall be equal to 15 Teaching Hours. If a course has 6 papers in semester, and each paper is having 4 Credits, then the total credits of the paper of the Semester shall be calculated 4 (credits per paper) \* 6 (number of papers) = 24 (Total Credits of the Subject). Grade Value shall mean the value assigned to the marks obtained by a student in a paper. Grade value is based on 10-point scale. Letter Grade shall mean the Alphabetical Grade/s determined on the basis of Grade Value obtained by the Student in a paper. The Grade Value on 10-Point Scale, and the letter grade to be given to the student, is on the basis of Grade Value obtained by the Student. The Table given below shows the marks range, grade value and corresponding lettergrade.

Grade Point shall be calculated by multiplying the Grade Value obtained by the student and the Credits of that paper. For example, if the student secures the Grade Value 08, and the Credit of the paper is 04, then the Grade Point of the student in that paper shall be 8\*4= 32. Semester Grade Point Average (SGPA) of a student shall be calculated as the sum total of the Grade Points secured by the student in all the papers of a semester divided by total Credits (sum total of credits of all the papers in that semester) in a semester

Cumulative Grade Point Average (CGPA) shall be the sum total of Quality points of all the Semesters of a course till date divided by Total Credits of the Course till date. CGPA shall be considered up to two decimal places. CGPA = Total Quality Points in a Course ÷ Total Credits of the Course

#### **Placement Procedure**

- 1. The Placement Cell will send the Placement Brochure and other relevant information to the potential recruiters. Any organization or recruiter tender interest in the recruitment, may contact at: <a href="mailto:placement@hpnlu.ac.in">placement@hpnlu.ac.in</a>
- 2. Pre-Placement Discussions (PPD): It will help students to know about the probably recruiters. This will also help the recruiters to go across all details about the students.
- 3. Pre-Interview Screening Process: this involves the screening process prior to the final interview. It may be group discussion or any other parameter which is decided by the recruiter after discussion with the Coordinator of the placement Cell.
- 4. Final Interview: On the basis of screening process, those students who are selected, shall be interviewed. As per the wish of the recruiter a waitlist of students, if needed, may be prepared to use in case of failure of appearance in interview by screened candidates.
- 5. Final intimation of Offer: The recruiter has to send the offer letter to the students through the Placement Cell only.

#### Note:

#### New Delhi-Chandigarh-Kalka-New Delhi

**Note:** There is sufficient frequency of trains from all major stations of Delhi and other cities of the Country to Chandigarh or Kalka, which is the last destination of broad-gauge trains to Shimla. From Kalka, however there is connectivity to Shimla via narrow-gauge toy trains. A couple of heritage trains run between Kalka and Shimla. It takes 4-6 hours to reach Shimla. There is smooth connectivity via road from Chandigarh and Kalka. There is also small airport at 10 kms distance from University, but it does not have routine flights. Therefore, reaching HPNLU, from Chandigarh is more feasible by own cars or taxi, which ply 24x7. Due to covid-19 the present schedule of flights the trains and the flights is not available. Once routine to and fro, flights and trains are restored, the relevant information will be supplied.
