- 1. **Mode of Examinations: (a)** Students are required to write Online, Open Book Examinations, by hand, on Physical Answer Sheets (A4 Size Paper)

- (d) A student who fails to join the link of Google Class Room, specified above or fails to undertake examination in any particular course or paper or upload answer script as prescribed belowshall be marked as 'Absent' in that papers. Such student shall have to undertake re-appear examinations for the course.
- 2. **Question Paper and Weightage of Marks:** The maximum total marks for the Question Paper (Each Course) shall be 50. The Question Paper shall consist of two sections *i.e.* Section A and Section B. Section A shall consist of 3 short answer type questions and Section B shall contain 3 long answer type questions, covering the entire syllabus. The students are required to answer any two questions, each, from Sections A and B.
