## **Degree Requirements:**

To be eligible for the award of the degree of MBA a candidate must secure a minimum 120 credits, subject to the following minimum conditions:

- i) In each individual course, a candidate must secure a minimum of 50% marks in internal assessment, practical exam, and semester-end theory exam to pass a course and earn credits in that course.
- ii) Attendance: 75% of total lectures delivered in all courses/papers, including Cleanliness Drive and Mentorship programme.

#### **Admission Process:**

## **Eligibility Criteria**

**Educational Qualifications**: Graduation (or equivalent) degree in any discipline from a recognized University established by law with at least 55% marks (50% marks in case of SC/ST candidates). Candidates appearing in the qualifying exam, i.e. Final year of the degree may also apply.

### **Selection Process**

Admission will be strictly based on the candidate's performance in the CAT/MAT/CUET examination Score, followed by a personal interview as part of the overall selection process.
