Important Information.

1. For admission to the B.A. LL. B. (Hons) program, candidates must have at least 50% aggregate marks in Class 12 (45% for SC/ST candidates).

- 2. For admission to the LLM program, candidates must have completed an LL.B. degree or an equivalent examination with at least 50% marks.
- 3. For admission to the Ph.D. in Law Programme, the NET score be used for the admission.
- 4. The University reserves the right to cancel admission if the candidate fails to submit the required documents or certificates by the specified date/time

Admission for the NRIs/Foreign Nationals & SAARC Nationals.

5. NRIs/ Foreign Nationals & SAARC Nationals seeking admission to the UG/PG programmes can apply directly to the University. Their admission is done on the basis of *inter-se-merit* of qualifying exam.

Facilities available.

- 6. **Hostels**. Himachal Pradesh National Law University, Shimla has separate Boys' and Girls' Hostels. There is a central mess facility for all the hostels. Hostel rooms are furnished with beds, study tables, chairs, and almirahs. Proper sanitation and hygiene are maintained in the hostel and the mess premises. The students are also provided with proper wi-fi connectivity. Transportation is provided for the residents of the hostels. For safety and security of hostel inmates, each hostel has security guards.
- 7. **Recreational Facilities**. Himachal Pradesh National Law University, Shimla Campus is equipped with recreational facilities for the residents. An open badminton court is currently operational along with indoor sports (gymnasium, table tennis, etc.) facilities. A full-fledged sports ground and other outdoor facilities are under construction.
- 8. **Health Facility**. University has Medical Care Centre. University has ambulance facility in the campus to provide emergency medical care from Government Hospital, Dhami and Indira Gandhi Medical College & Hospital (IGMC), Shimla.
