- 2. No students shall be allowed to reside in the Hostel without submission of Mess Fees.
- **3.** Students are required to pay the fees through ERP. No fee will be accepted except ERP (SBI Epay).
- **4.** Mess Fee is compulsory for all Hostel residents. Further, Non-Residents to Hostels seeking exemption from Mess facility are required to apply for Mess Fee exemption through Dean Student Welfare.
- **5.** The 1st year students who have joined the University later at the time of admission in Academic Session 2024-25 and paid the full Mess Fee, their excess Mess Fee has already been adjusted and updated accordingly in the ERP.
