NOTIFICATION

This is with reference to the email sent from the Office of the Registrar on 30th November, 2022 and on 2nd December, 2022 notifying the list of admitted and not admitted students to the respective years, i.e. 2nd 3rd 4th and 5th, B.A./B.B.A.LL.B. (Hons.) (FYIC) (Academic Session: 2022-2023) and the Notice issued from the office of the Registrar with Ref. No. HPNLU-B (15)-92(R.O)/2021-753, dated 06.12.2022, declaring the list of year back students.

The representation received from the students in this regard have been (on the basis of proposal of Controller of Examinations), reconsidered by the University. In view of the fact that for about two years (from third week of March, 2020) University remained close for students and all Academic activities and Examinations were carried through online mode. The University reopened for the purposes of all Academic, Examinations and other activities in physical mode, in the third week of March, 2022.

In the month of May, 2022 all such students were allowed a Special Reappear Examinations in order to clear their backlog papers of the Examinations, which were held during the period of two-year closure of the University due to COVID lockdown. The said Special Reappear Examinations, permitted the students for written as well as internal component of examinations (i.e. Assignments/Presentations). Besides grant of the said chance, some of the students could not clear their backlogs.

Therefore, in view of the above, it has been decided that all the students who failed to clear the paper(s) in any of the examinations held during the COVID period only (i.e. March, 2020 to March, 2022) and got year back or has backlog papers, or wants to improve grade in any paper, from any of the relevant previous terms, are hereby promoted on provisional basis, to their next respective semesters/years. Further, a final chance is also granted to all the students to clear the backlog of their reappear papers of the COVID period and also allowed to submit assignment/presentation of the said period.

Such students are required to fill up the Reappear Examinations Form by paying the Reappear Examinations fees (i.e. Rs. 1000/- only per paper) in the Accounts Branch of the University, before 30th December, 2022, through ERP Link (link will be shared separately). The said examinations will be held as soon as the University reopens after the Winter Vacations, i.e. in February, 2023.

This is again clarified that no further chance shall be given to such students in future (for passing papers which are backlog from the COVID-19 period of two years) and thereafter all cases shall strictly be dealt with in accordance with the relevant Regulations of the University including Rule 13 of the Examinations Regulations. Further, this order/notice shall not be applicable to cases which arose prior to March 2020 or may have arisen/shall arise after march 2022.
