### NOTIFICATION

“The University is in receipt of instructions from its counsel regarding the interim orders passed by the Hon’ble High Court in CWP no. 549 of 2021 on 10-03-2021. As per the understanding of the counsel for the university, the students (2<sup>nd</sup> , 3<sup>rd</sup> , 4<sup>th</sup> and 5<sup>th</sup> years) have been directed to pay the 50% of the totally fee due within 5 days [as stipulated in the actual orders, whose copy is not yet received] and the remaining 50% fee has to be paid prior to the declaration of the results. As such, those students, who are keen to avail the benefit of the orders of the Hon’ble High Court, should immediately mail an undertaking through the Google Form(Link given below) to the effect that they shall pay 50% fee within the time stipulated by the Hon’ble High Court in terms of its orders dated 10-03-2021, subject to which they be allowed to participate in the on-going examinations which are scheduled to commence from 12-03-2021. They shall be giving a further undertaking that they shall pay the remaining fee before the starting of the classes or before the declaration of the results, as the case may be. This is subject to the orders of the Hon’ble High Court. The notice may be revised upon receipt of actual orders of the Hon’ble High Court. The undertaking must be received by email within 24 hours and the same should be categorical unequivocal and unconditional.”

It is hereby notified that all students desirous of availing the benefit of the above order of Hon’ble High court, are required to submit within 24 hours a categorical, unequivocal and unconditional undertaking in the following terms through the Google Form:

I, ..... S/O or D/O ..... student of BA/BBA LL.B. 2/3/4/5 year; Enrolment No.-..... (HPNLU, Shimla) hereby categorically, unequivocally and unconditionally undertake that I shall pay the 50% of the totally fee due (academic Sessions- 2019-2020 and 2020-2021) within 5 days [or within 7 days as stipulated in the actual orders of the HP High court, dated 10-3-2021]. I further undertake that, I shall pay the remaining 50% fee due

before the date of declaration of results of the above examinations, that is, on or before 31<sup>st</sup> March, 2021.

The results of the above examinations will be declared by 31<sup>st</sup> March, 2021. Any student who fails to submit the required undertaking within 24 hours, that is, by 2.00PM, 11-3-2021, shall not be allowed to appear in the examinations. It is further notified that any student who fails to pay the remaining 50% of fee due prior to 31<sup>st</sup> March 2021, his/her results shall be withheld and shall not be allowed to attend next semester classes which are proposed to start on 1<sup>st</sup> April, 2021.

This is subject to the orders of the Hon'ble High Court. The notice may be revised upon receipt of actual orders of the Hon'ble High Court.
