Instructions:

- 1. Candidates are advised to strictly follow the procedure prescribed by the CLAT 2025 Office for completing the Admission formalities circulated vide Consortium of National Law University Notice dated 17th May, 2025.
- 2. Only those candidates who have been allotted the Himachal Pradesh National Law University, Shimla and have chosen Freeze option by paying Counselling Registration fee of ₹ 30,000/- (for General Candidates) and ₹ 20,000/- (for SC/ST/OBC/BC/EWS/PWD) and Confirmation fee of ₹ 20,000/- to CLAT Office, are required to pay the first installment of Annual/ Semester Fee for the Academic Year 2025-26 to HPNLU, Shimla as per courses details given below:-

- 3. In case the student is getting upgraded from other NLU to HPNLU, Shimla he/she shall be required to submit the Admission Fee by adjusting the fee deposited at earlier allotted NLU.
- 4. The candidate shall take extra precaution to ensure that the admission fee is duly deposited within the time notified by the CLAT Consortium/ HPNLU. Admission shall not be confirmed until the fee is received by the University, and non-receipt of fee will result into rejection of the application form.
- 5. Candidates are required to register for B.A./B.B.A. LL.B. Hons. (FYIP) is https://erphpnlu.in/login.htm. To fill the admission form, payment of Semester fee electronically and upload self-attested scanned copies of the following documents for completion of Admission formalities at Himachal Pradesh National Law University, Shimla.

In cases where candidate fail to submit the certificates relating to qualifying examinations, provisional admission will be allowed to all such candidates within a week from the declaration of the result/ receiving the certificate. In case of unavailability of such certificates, student shall submit an undertaking (Annexure-I). However, failure to submit such certificate, the date prescribed by the University will result into automatic cancellation of admission, and the HPNLU/UGC fee refund policy will apply accordingly.
- 8. Applicable valid category certificate/s such as Caste, Bonafide Himachali,/ PwD, Foreign Nationals, NRI, OBC, EWS, J&K Resident, Wards of J&K Migrants etc. shall be mandatory at the time of admission itself. No relaxation will be granted in this regard.
