

#### CENTRE FOR ENVIRONMENT AND DISASTER MANAGEMENT

The Centre for Environment and Disaster Management (CEDM) is a specialised Centre for conducting socio-legal research in environment protection & disaster management and assisting the government in making better laws and policies. The CEDM newsletter "HPNLU Green Gazette" endeavours to create a space that fosters independent academic thought, inculcates a culture of research and ignites conversations on matters of environmental jurisprudence and environmental values.

#### CENTRE FOR LAW, BUSINESS AND ECONOMICS

The Centre for Law, Business and Economics aims to give a necessary impetus by inculcating an outlook amongst those future corporate professionals. They question the various aspects of business and its interplay with society. The Centre's study focuses on the wide-ranging contemporary corporate law issues of financial markets, intermediaries, and corporate law's legal framework.

#### CENTRE FOR CHILD AND WOMAN STUDIES

"Arise, awake, and stop not till the goal is reached" is the motto of the Centre for Child and Woman Studies, a specialised Centre for conducting socio-legal research in the field of rights of women and children. It further aims to initiate and promote regional, national, and international collaboration and fund-raising for women's and children's causes. The Centre has organised a two-day webinar on "Reproductive Rights of Women in the Changing World: Expressing Autonomy of Choice", having Hon'ble Justice Indira Banerjee (Judge, Supreme Court of India) and Hon'ble Justice Geeta Mittal (former Chief Justice J&K High Court) as distinguished speakers.



### Student Committees

#### CAMPUS MENTORING AND COUNSELING CELL

#### MOOT COURT COMMITTEE

The Moot Court Committee (MCC) of HPNLU, Shimla, thrives on ensuring that moot court events, which are an intrinsic part of the lives of law students, are encouraged and provided to every student for their holistic health development in their law career. Moot Court exposes students to various legal issues and research and develops oratory and argumentative skills. A practical exposure and mooting culture is fed by MCC on the campus by organising intra and National Moot Court Competitions. Students of HPNLU are encouraged to take part in various National and International Moot Court Competition and



are provided mentorship by committee members and faculties of HPNLU. In the term 2021-22, MCC has conducted two of our flagship national moot court competitions and an intra-university competition despite a challenging time in the pandemic.

#### PARICHARCHA DEBATING SOCIETY

Debating is an essential skill for a law student, and Paricharcha, HPNLU's Debating Society, has always worked towards inculcating this art in all the students. To inculcate the skill of debating, it conducts weekly debate sessions on contemporary themes and encourages students to participate in National and International Debate Competitions.

#### LEGAL AID CLINIC

Legal Aid Clinic HPNLU working under the Nyaya Bandhu Pro-Bono Scheme provides day-to-day legal assistance to High Court and District court advocates working on pro-bono basis in Himachal Pradesh. Further, the LAC offers community care legal assistance by organising Legal Literacy Camps, providing free legal aid to aggrieved, organising various other law awareness programmes such as nukkad nataks, informative seminars etc. Pro-Bono Associates at LAC constantly offer legal assistance to aggrieved citizens and, at the same time, assist the advocates for research and drafting. All-in-all, the Legal Aid Clinic HPNLU, from its inception in 2016, has been a cornerstone of the co-curricular aspect of HPNLU and has played an essential role in improving the overall learning of law.





#### **CULTURAL COMMITTEE**

It conducts Poetry Writing, Singing, Dancing, Storytelling, and modelling, among other events throughout the year. **Pre-Placement Talks:** Organisations seeking to recruit from HPNLU can hold pre-placement talks in consultation with PAC. Organisations are free to use any method of its convenience to conduct pre-placement discussions. Organisations are encouraged to conduct an interactive session, either on-campus or through video conferencing, highlighting the salient features of the organisation, the job profile being offered, remuneration, terms and conditions of employment and other relevant information as the Recruiter thinks fit any time before the screening process.

**Pre-Interview Screening:** Recruiters can conduct a Pre-Interview Screening Process, including group discussions before the interview day. Recruiters are free to determine their own policy for the Screening Process to shortlist students. If the Recruiter has no particular method of Pre Interview Screening, the Cell shall forward the Curriculum Vitae of all interested students to the Recruiter.

**Final Interview:** Based on the screening process, those selected students shall be interviewed. As per the Recruiter's wish, a wait list of students, if needed, may be prepared to use in case of failure of appearance in the interview by screened candidates.

**Final intimation of Offer:** The Recruiter has to send the offer letter to the students through the Placement Assistance Cell.

Recruiters can visit the Campus for the placement procedure or opt for any suitable mode they deem fit.
