#### **ORDER**

(Holding of Reappear/Improvement Examinations and End-Term Examinations)

The University is keen to conduct End Term Examinations of 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup> semesters, Academic Session 2020-2021, and remaining reappear/improvement examinations of 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> semesters, Academic Session 2019-2020, at the earliest. The current session, for 4<sup>th</sup>, 6<sup>th</sup>, 8<sup>th</sup> and 10th semesters has already been delayed considerably. It is worthwhile to notice that several students of 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> years have not paid fee for Academic Sessions 2019-2020 and 2020-2021, i.e. 2<sup>nd</sup> instalment of the year 2019-20 and for the first and second instalments of year 2020-2021, despite repeated reminders, requests and notices calling upon them to pay the fee. It is pertinent to mention that only a few students have since approached the University authorities giving complete justification for sympathetic consideration, backed by due documentation as proof for extension of time to pay fee on account of financial constraints. Based upon the material produced by them, they were duly allowed extension of time for remittance of fee. Added thereto, the annual addition/ increase of the fee has not been charged from any of the students in the Academic Session 2020-2021. The University is paying huge rentals towards the hostel buildings taken on rent from the private owners, as the University does not have its own hostels so far. Added thereto no grant in aids have been received from the Govt of HP after the financial year 2016-2017. There is a huge liability to pay the outstanding allowances to the Teachers and huge other liabilities are required to be met. The University is already having a deficit of more than Rs. 12 Crores.

It is quite shocking that even till date, the overwhelming majority of the students who have not paid fee, that too without assigning any tangible reasons, did not approach the University authorities furnishing any specific reason or presenting any documentary evidence substantiating financial difficulty, seeking extension of time in respect of remittance of fee. The University session stands already delayed considerably due to non-holding of the examinations.

As on today there are about 70% students who have paid fee. However, there are still about 30% students who have not paid fee. There is thus no justification for delay in holding these examinations and to further prejudice the interest and cause losses to those students who have already remitted the full fee. In the circumstances a conscious decision has been taken by the University, to schedule and notify the examinations subject to the following conditions: -

- a. Only those students who have paid full fee till date and who are consequently on the rolls of the university, shall be eligible to appear in these examinations.
- b. Further, those students who have already approached the University authorities with genuine request producing documentation showing genuine financial constraints on account of financial difficulties and who have been allowed additional time by the University authorities, shall also be permitted to appear in these examinations.
- c. The students who have not paid fee for Academic Sessions 2019-2020 or 2020-2021, i.e. 2<sup>nd</sup> instalment of the year 2019-20 and the first and second instalments of year 2020-2021, are thus not borne on the academic rolls of the University, and even though as a concession they were allowed to attend the Online classes, they shall, however, not be allowed to appear in these examinations, in terms of the approval of the Hon'ble Chancellor, unless they remit the requisite fee on or before March 10<sup>th</sup>, 2021.


