***Note** – For the post of Professor of Law or Associate Professor of Law –

- a. ***Candidates applying for the post of Professor of Law or Associate Professor of Law are required to fill up prescribed API Score Form and upload the Form. The candidates are advised to carefully read the API Score Criteria (Annexure – I) before filling the form.***
- b. The candidates applying for the post of ***Professor of Law or Associate Professor of Law are required*** to apply online and **submit hard-copies as specified below**. The candidates are requested to download the completed On-Line Recruitment Application Form from ERP portal and attach, the completed API Form and also attach all the supporting documents/ certificates for the specific API Points claimed in the API Score Form. - c. The complete copy, ***including cover, copyright, ISSN/ISBN No., authorial page,*** etc., pages, of all publications, claimed by the candidate, is required to be submitted in hard copy.
- d. **The last date for receiving the hard copies of the application form along with all other supporting documents/ certificates is – 07.08.2022. The University shall not be responsible for any postal delays.**

INSTRUCTIONS/ CONDITIONS AND ESSENTIAL QUALIFICATION(S) AND EXPERIENCE ETC.

- i.** Candidates applying for the specific posts are required to fill in the prescribed application form and upload (On-Line Recruitment Application (ORA) Form).
- ii.** The University reserves the right to dispense with the written examination for any non-teaching post keeping in view the number of applications viz-a-viz vacancies and other circumstances. In lieu of marks for written test, the University may prescribe a direct selection criterion based on essential qualifications prescribed in the Regulations, (as applicable), and may directly conduct the Interview, Skill test/ evaluation of all the eligible applicants, as the case maybe.
- iii.** Date for determining eligibility of all candidates in respect of Essential Qualification(s) and Experience, if any, etc. shall be determinable according to the prescribed closing date for submission of On-Line Recruitment Application (ORA) Form.
- iv.** **Age:** The minimum and maximum age limit of 18 to 45 years respectively shall be determinable according to the prescribed closing date for submission of On-Line Recruitment Application (ORA) Form (applicable to non-teaching posts).
- v.** The upper age limit is relaxable by five years for candidates belonging to Scheduled Caste, Scheduled Tribe and Other Backward Classes, Persons with disabilities & Children/Grand Children of Freedom Fighters of Himachal Pradesh.
