The pandemic Covid-19 has taught us about the limits of class learning. In future, the students should be allowed to learn more through field work and evaluated accordingly. Online learning is going to be the base through which the students, across the courses will be trained. Ministry of Human Resources, Government of India, and the University Grant Commission both are focussing on different techniques of Online Learning. Thus, the *contact lectures* through *virtual classes* will soon going to be the reality. In such a scenario, the clinical legal education can contribute immensely in not only application-based learning but also intense filed research.

The clinical legal education is not a term of art. The clinical legal education implies greater idea in which institutions should provide a learning environment wherein learner's skill could be honed effectively to identify the [legal] issues and resolve them through application of [legal] knowledge in diversified areas of law. The Certificate of participation will be issued only when the participant attends all the sessions of the FDP through online mode.
