2.) Time for Counseling is from 10.00 am to 03.00 pm. Reporting time is 10.00 am.

 - (iv) Migration Certificate from School/Board/University last attended
 - (v) Character Certificate from Educational Institution last attended
 - (vi) Category Certificate issued by competent authority/Himachal *Bona fide* Certificate issued by competent authority (if applicable)
 - (vii) In case of a Gap year - a self-declaration to the effect that student has not taken admission during the period in any Institution/University
 - (viii) Copy of Aadhaar Card (UID)
 - (ix) Four Photographs (Passport size)
 - (x) Printout of CLAT Counseling Fee deposited (Rs. 50,000/-)
 - (xi) Soft copy of passport size photograph (JPG in a pen drive)
 - (xii) One set of Attested Copies of the documents mentioned in above points from I to VI (Self Attested)
5.) Fee to be paid: Students who have paid Initial Counseling Fee amount to CLAT Office should pay the remaining said remaining amount in the form of Draft/Cash.
 - (i) Tuition and Allied Fee Rs. 1,10,500/-
 - (ii) Advance Mess Charge Rs. 20,000 + 3000 (mess security deposit, one time); Total:23,000/-
- 6.) Mode of Payment - The fee is payable through two modes only :
 - (i) Through two separate Demand Drafts for Fee and Mess Charges separately in favour of **Registrar, Himachal Pradesh National Law University, Shimla; Payable at Shimla.**
 - (ii) Through Cash to be deposited at State Bank of India Counter, set up at the Admission Venue, HPNLU, Shimla.
