### HPNLU FEE REFUND POLICY (ACADEMIC SESSION 2022-23)

The Himachal Pradesh National Law University, Shimla, in accordance with the 'UGC Fee Refund Policy 2022-23 notified vide D.O. No. 2-71/2022(CPP-II) dated 2<sup>nd</sup> August, 2022, has revised the Fee Refund Policy to be applicable for the Academic Session 2022-23:-

- 1. In case of written request for withdrawal/Cancellation of admission is received up to October, 31<sup>st</sup>, 2022, all fee including all charges shall be refunded.
- 2. In case of written request for withdrawal/Cancellation of admission is received on or after November 1<sup>st</sup>, 2022 and up to December 31<sup>st</sup>, 2022 all fee collected from the students shall be refunded after deducting ₹ 1000/-(Rupees One Thousand Only) as processing fee.
- 3. With respect to written request for withdrawal of admission is received on or after January 01st, 2023:-
  - (i) That the candidate may be allowed to withdrawal of admission his or her admission subject to deposition of annual fee and formal clearance from the University in the prescribed format enclosed herewith.
  - (ii) No migration/No Objection Certificate (NOC) can be issued in such cases, until the applicant submits original transfer certificate of his qualifying examination.
  - (iii) In case written request for withdrawal of admission is received on or after January 1<sup>st</sup>, 2023 but before the commencement of 2<sup>nd</sup> semester, the students will be refunded with all refundable securities, the fee deposited for the 2<sup>nd</sup> semester, and the hostel fee, if no hostel was allotted to such student.

- 4. Students seeking withdrawal/ cancellation of admission are required to fill the Withdrawal/Cancellation Form enclosed herewith.
- 5. The above guidelines shall be subject to any further notification issued by the University Grants Commission (UGC), New Delhi.
