Q.1 Short Answer Type Questions:

- 1. An association consisting of 120 members including Mr. Ram and Mr. Shyam, who are also its directors. On 20th April, 2020, all the members except Mr. Ram left India for a business meeting. On 25th April, 2020, all died abroad due to Covid-19. On 5th May, 2020, Mr. Ram purchased on credit of Rs. 100000 worth of goods from Mr. Indra on behalf of the association. In this regard, Mr. Indra wants to make Mr. Ram personally liable. Decide whether Mr. Ram liable?**

2. Mr. Z was shareholder in tea company (which carrying on business of growing and manufacturing tea) and was receiving regular dividends. The income tax department assessed Mr. Z for the income derived from the tea grown and manufactured. Mr. Z contended that his income is exempted from the tax as the same is agricultural income. Decide with relevant legal provision and case law.
3. Ms. Radha appointed as independent director of a private limited company. Later on, it was revealed that she is related to Mr. Mohan, who is also a director of the company. Therefore, her appointment was nullified. Decide the nullification in the light of the relevant provision of the Companies Act, 2013.
4. Write a short note on 'Oppression and Mismanagement' with the help of statutory provisions.
5. Mr. X and Mr. Y doing business separately, agreed to amalgamate their business by forming a company of which they were the only shareholder and director. On some issue they became hostile to each other. Can the company be wound up? Explain with statutory provision and decided cases.
6. Describe the power of National Company Law Tribunal to call Annual General Meeting.

Q.4 The Farm Fresh Company was incorporated with the objective to business in Sugar and Cement. Due to the rising price of these commodities the government brought them into the list of essential commodities by virtue of the power conferred under section 3 of the Essential Commodities Act, 1955, which empowers the administration to regulate the supply and price of these commodities. As a result, the prices of the same commodities fall sharply. In the board meeting of the company it was decided that in the reduced-price situation, the company will not continue the business. In this regard the company filed the petition to wind up. Decide with the help of relevant statutory provision and case laws.

Q.5 Explain the concept of meeting in Companies Act, 2013. Discuss the procedure to call the different kinds of meetings with the help of Companies Act, 2013.

Q.6 In a Land Developer Company Mr. Z was a managing director. While negotiating on behalf of the company, he decided to personally bid on a contract. Subsequently, he pretended to be ill so that he could leave the company at short notice. Mr. Z then took up the contract and made a large personal profit. Q.1 Short Answer Type Questions:

- 1.** Define and distinguish between facts in issue and relevant facts with the help of examples.
- 2.** A, B and C are charged with attempt to murder and conspiracy to murder R (wife of A). A procured gun for the purpose, B arranged for the vehicle and C arranged for safe passage and stay after the crime. Before the attempt was made, C was arrested and he disclosed the entire sequence of events to police and also narrated the role of each co-conspirator and the things said, done or written by

other conspirators with reference to the common intention of murder of R. The statement is recorded u/s 164. It is further alleged that from jail also he was in touch with other co-conspirators and ultimately there was attempt to murder. Discuss the relevance of the statement under section 10 of the Indian Evidence Act.

3. In a suit brought by B against A for damages for having deceived him by pretending to be the agent of a well reputed firm of Mumbai, evidence is tendered that A made a similar representation to X in a neighbouring town. The evidence is being objected to as being of unconnected transaction. Decide the question of relevancy.
4. When previous judgments between non-parties become relevant in a subsequent suit.
5. How would you prove a “Will” of which attesting witnesses are dead or known to be hostile?
6. How would you prove a ‘*Sanad*’ granted by Emperor Akbar, granting a village to a temple?

Q.2 “Presumption is a rule where if one fact which is known as the primary fact is proved by a party then another fact which is known as the presumed fact is taken as proved if there is no contrary evidence of the same”. In the light of this statement discuss the law relating to obligatory presumptions under the Indian Evidence Act.

Q.3 “Mr. White wants to get rich quick by whatever means possible. He decides that the best way to do so is to rob an ATM. Realizing that it would be a two-person job, he contacts Mr. Pinkman to help him carry out this plan. But, two days after planning the theft, Mr. Pinkman gets cold feet and wants to back out. He sends a text message to Mr. White saying, “I withdraw my consent to do anything and everything that you proposed. Please don’t contact me.”

But as it turns out, the police was already on the lookout for Mr. White as he had prior record for some petty crimes. They somehow got the wind of the

fact that there was a robbery being planned. Subsequently they arrest Mr. White and Mr. Pinkman and prosecute them for conspiring to commit robbery.

Can the text message sent by Mr. Pinkman to Mr. White be relevant evidence under Section 10 of the Indian Evidence Act, 1872?

Q.4 When 'right' or 'custom' is in question, discuss the relevance of the following:

- (a) Recitals in documents not inter parties.
- (b) Judgments not inter parties.

Q.5 A person is tried under NDPS Act and he pleads juvenility. He intends to produce school leaving register for proving his juvenility. The trial court has directed bone ossification test and has ignored school leaving register. Discuss and decide.

Q.6 A made a public speech wherein he made statements against a particular religion. He called upon people belonging to his religion to flush out the people belonging to other religion claiming that they are destroying their culture and identity. A person who heard the speech recorded the entire statement. He lodged a FIR against A for promoting religious enmity among other things. He transferred the speech recorded by him in a CD and handed over to the Investigation officer. IO produced CD and the transcripts of the speech in court as evidence. Whether this evidence is admissible? Referring to the applicable provisions of Indian Evidence Act and judicial precedents decide the conditions for production and admissibility of such evidence along with its evidentiary value.

Q.7 Vijay is a student at the Punjab University. The attendance rules of the university published in the academic calendar and also put on the notice board, indicate that a student failing to put in a minimum prescribed percentage of attendance will not be allowed to write the exams.
