3. Preventive Maintenance (PM)

This consists of measures as necessary to maintain, clean & reconnect the equipment in a proper operating condition. It includes functional checking, necessary adjustments, and the measure is to be carried out in advance and during the working hours (Monday to Saturday) from 9:30 am to 5.30 pm.

4. Breakdown Maintenance (BM)

This is to be carried out in the event of a malfunction, which prevents the operation of the equipment. The work is to be carried out within 24 hrs after receiving verbal/written/email complaints. It includes fault finding repair or replacement of defective parts and functional checking during the working hours as ibid.

If any component of the UPS is found to be non-operational for a long time, the Company should provide standby support system/peripherals/components with the same or higher/new configuration/specification within 24 hours. If, the company fails to provide the breakdown services made within the stipulated time as mentioned in scope, a proportionate amount of money from the contract against the faulty UPS shall be deducted.
