Eligibility Criteria

The competition is open to students pursuing under-graduation from any recognised University in India and is open to the students who are pursuing five year as well as three year LLB course from a recognised University/Law School.

Submission Guidelines

- 1. The manuscript should be accompanied by a Cover Letter specifying the author's name, designation, institution name, contact number, and email for future reference.
- 2. At the time of submission of Essay the author is required to give an undertaking that the article/essay is his/her original work and has not been submitted, accepted or published elsewhere.
- 3. Co-authorship is not allowed.
- 4. The similarity index should be below 10%. Plagiarism will result in summary rejection of the submission.
- 5. The length of the essay must not exceed 5000 words including endnotes.

Submission Guidelines

- 6. All submissions must be in English.
- 7. The contents should be in Times New Roman with font size of 12, 1.5 line spacing and 'justified' alignment.
- 8. The article should contain endnotes and not footnotes. All endnotes must be in Times New Roman font, with size 10 and line spacing 1 and 'justified' alignment.
- 9. All submissions must follow the Bluebook (20th Edition) style of citation; non-conformity will be subject to rejection.
- 10.Submissions must be made in .doc/.docx formats only.
- 11.Entries not following the above instructions will not be accepted.
